


#### Q1 Overall, how would you rate the operations and governance of the Peregrine HOA Board







## Q3 When considering the services provided for your annual HOA fees, do you feel the fees are:





## Q4 Do you feel Peregrine's Protective Covenants meet the requirements of today's owner/residents?








